

FY2023 Consolidated Appropriations Act (Public Law 117-328) Key IDSA Funding Priorities Summary

Department of Health and Human Services

 Authorizes the BIO Preparedness Workforce Pilot Program to provide loan repayment of up to \$50,000 per year for up to three years for ID and biopreparedness health care professionals in health care professional shortage areas, medically underserved communities and certain federal facilities including Ryan White clinics.

Centers for Disease Control and Prevention

- \$9.2 billion for CDC, an increase of \$760 million
- \$197 million for the Antibiotic Resistance Solutions Initiative, a \$15 million increase
- \$24 million for the CDC National Healthcare Safety Network, a \$3 million increase
- \$40 million for CDC Advanced Molecular Detection, a \$5 million increase
- \$692.8 million for the Center for Global Health overall, a \$46 million increase, and \$293.2 million for Global Health Protection, a \$40 million increase
- \$23 million for the Infectious Diseases and Opioid Program, a \$5 million increase
- \$58.7 million for quarantine support, an \$8 million increase
- \$62.6 million for vector-borne diseases, an \$8 million increase
- \$681.9 million for the Immunizations Program, a \$31.2 million increase

National Institutes of Health

- \$47.4 billion for NIH overall, a \$2.5 billion increase
- \$6.562 billion for the National Institute of Allergy and Infectious Diseases overall, a \$294 million increase, and \$565 million for AMR research, a \$25 million increase
- \$95.1 million for the John C. Fogarty International Center, a \$8.2 million increase

Assistant Secretary for Preparedness and Response/Biomedical Advanced Research and Development Authority

- \$950 million for BARDA overall, a \$204 million increase
- \$820 million for Project Bioshield, a \$40 million increase
- Report language that aligns with the Pioneering Antimicrobial Solutions to End Upsurging Resistance (PASTEUR) Act to revitalize antimicrobial R&D, delinking antimicrobial revenue from volume of sales

Centers for Medicare and Medicaid Services

Report language requesting an update on the process for more comprehensively evaluating E/M codes

State Department and U.S. Agency for International Development

- \$394.5 million for the USAID global tuberculosis program, a \$23.5 million increase
- \$900 million for USAID global health security, a \$200 million increase
- \$692.8 million for the CDC Center for Global Health overall, a \$46 million increase, including \$293.2 million for CDC Global Public Health Protection, a \$40 million increase, and \$11.7 million for global TB, a \$2 million increase
- \$4.395 billion for the U.S. President's Emergency Plan for AIDS Relief, a \$5 million increase
- \$2 billion for the Global Fund, a \$440 million increase
