# **Benefits of Designation**

Designation as an IDSA Antimicrobial Stewardship Center of Excellence is the highest recognition a hospital stewardship program can achieve and the only recognition in the ID field. Designed by IDSA members, this prestigious program recognizes the accomplishments of stewardship programs that demonstrate excellence by exceeding the CDC Core Elements for AS and incorporating quality and policy measures to improve antibiotic use based on evidence and clinical outcomes. Since 2018, over 180 hospitals have received CoE designation, with 80% renewing. From the initial group of designated hospitals, 75% have maintained continuous designation in the program.



## What are the benefits of CoE designation?

#### **Increased Stewardship Recognition & Support**

IDSA recognizes designated hospitals with a certificate and listing on IDSA's public website and in a press release. Hospitals receive marketing resources to promote their designation locally. Some CoE members have shared that this recognition of their AS program has increased leadership visibility of their initiatives and assisted them in obtaining increased funding and resources.

#### **Best Practice Sharing and Education**

IDSA hosts regular webinars and online journal club meetings for CoE hospitals only, where members hear from subject matter experts on current topics in AS and discuss recent publications. Members also share their strategies and improvement projects to learn from each other and work collaboratively.

### **Resource Library**

A private section of the IDSA website for CoEs contains a library of resources to support designated hospitals in their ongoing AS activities and improvement initiatives. These include webinar recordings and materials and AS tools shared by CoE hospitals.

#### **Networking & Stewardship Support**

CoE hospitals are part of a select community of over 150 hospitals. Members have access to a private, online network to connect with peers, share ideas, and collaborate on quality and research opportunities. Smaller or resource-limited hospitals can find support and resources for their AS efforts from the community by contacting larger academic medical centers or community hospitals for ideas and strategies.

#### **IDWeek Reception & Activities**

IDSA hosts a special reception for CoEs at IDWeek, providing a great opportunity for members to meet and reconnect in person with peers and program leadership. Other activities are held throughout the week for CoE members only and to promote the work of designated hospitals.

### **Supporting Accreditation & Regulatory Compliance**

Surveyors from accreditation and regulatory agencies, such as The Joint Commission, acknowledge CoE designation positively, and members note that maintaining designation provides a practical advantage in staying prepared for surveys.

## Where are designated CoEs located?

Over 150 hospitals are designated as CoEs across the USA and internationally.
